USE OF HDPE/MDPE PIPES & uPVC PIPES IN MAP

1. Further to our Policy Letter No 02/2005 dated 04 Feb 2005 issued vide our letter No 21316/PIPES/P&S/42/MAP dated 04 Feb 2005.
2. Water Distribution System. In addition to the makes given under Para 2(a) of above referred policy letter; after techno-economic evaluation by Product Approval Committee of DG MP; for wider availability, upto 110mm dia Polyethylene pipes (PE-80/100 grade) i.e. HDPE pipes as per IS: 4984-1995 & MDPE pipes as per ISO:4427-1996 of Jain Irrigation System Ltd, Jalgaon have been approved for incorporation in MAP works. The firm has offered 10% discounts on their price list (inclusive of 16.3% excise duty & cess) and has confirmed validity of existing price list upto 31 Oct 2006. If the company price lists are revised after one year, discount offered shall remain effective on revised price list.
3. Rainwater Pipes & Fittings. uPVC pipes as per IS: 4985 of Finolex / Supreme / Jain Irrigation / Ori-Plast / Reliance are approved for incorporation in MAP works.
4. Further technical details of the products, samples may be obtained in due course from the manufacturers as given at Appendix A. Consequent to evaluation, approval of additional firms manufacturing above / identical products shall be communicated.
5. Para 6. In partial modification of Para 6 of Policy Letter No 02/2005, for projects where contracts have been concluded, changes shall be carried out on case-to-case basis, depending upon contractual implication, financial health, present progress of the project; in close coordination with and prior approval of Planning Team of DG MAP.
6. No other change is there in above referred policy letter.
