1. Further to DG MAP Policy letter No 21/2007 dated 02 Nov 2007.
2. For wider availability of 'Ply Board / Block Board, Pre-laminated Particle Board, Plain/Veneered Particle Board' and to generate healthy competition; after techno-economic evaluation by Product Approval Committee of DG MAP; 'Ply Board (IS: 303) / Block Board (IS:1659), Pre-laminated Particle Board (IS: 12823), Plain Particle Board (IS: 3087) / Veneered Particle Board (IS: 3097)', ISI marked in respect of the following firms have been approved for incorporation in MAP works:-
 - (a) M/s Novopan Industries Ltd for prelaminated particle board.
 - (b) M/s Shirdi Industries Ltd (**BRAND-ASIS**) for plain/prelaminated particle boards, plain & prelaminated MDF, high pressure laminates / commercial & decorative veneered particle boards.
 - (c) M/s Merino Group of Industries for high pressure laminates, plywood, blocks board, laminated plywood, blocks board, plain prelaminated particle and MDF Boards.
