USE OF FLUSH DOORS IN MAP

1. Reference DG MAP policy letter No 08/2005 dated 11 Mar 2005.
2. With the view to ensure that quality specification / product are only incorporated in MAP while the base for availability remains wider, approval for undermentioned Makes of flush doors (as per MAP specifications enumerated vide Para 3 of policy letter No 08/2005) is accorded:-
 - (a) M/s Anand Wood Crafts, Secunderabad
 - (b) M/s Kitply from their Margherita unit Tinsukia (Assam).
 - (c) M/s Rama Wood Crafts, Satna (M.P)
3. Further technical details, samples of product may be obtained in due course from the manufacturers as given on Appendix A.
4. Consequent to evaluation, approval of additional firms manufacturing above / identical products shall be communicated.
5. Deviations. Deviations in the existing contracts from paneled doors to flush doors or otherwise shall be priced in accordance to provisions of SSR of MES. However, provisioning shall be done from the Makes approved by DG MAP.
6. Executing Agencies / Consultants / Project Manager & Technical Advisor would ensure that quality / genuine products are incorporated, excise duty gate passes are insisted and mandatory tests for assuring qualitative standard are carried out. Record of the same shall be maintained. Performance feedback shall be submitted by Project Managers/Technical Advisors during execution and defect liability period. Defects / discrepancy, difficulties noticed shall also be promptly reported to HQ DG MAP for considering continuation of the products.
